An Election to Lok Sabha from 1- Daman & Diu Parliamentary Constituency is to be held on 30-04-2014 (Wednesday). On issue of Notification by the President of India, under sub-section (2) of Section – 14 of the Representation of the People Act, 1951 (No. 43 of 1951) on 02-04-2014 calling upon the Parliamentary Constituencies in Union Territory to elect member to the House of the People, the Election Commission of India on 02-04-2014 has notified the following Polling programme for (U04) Daman & Diu Parliamentary Constituency Containing various states of Election.

As required under Section -31 of the Representation of the People Act.1951 the Returning Officer Daman & Diu Parliamentary Constituency has issued Notice of Election (Form-1) inviting nominations from the intending candidates.

1. Nominations papers should be delivered to the Returning Officer in his office at the Collectorate, Daman between 11.00 A.M. to 03.00 P.M. (excluding Public holiday) w.e.f. 02. 04.2014 to 09.04.2014. Besides the Returning Officer, Shri Gaurav Singh Rajawat, Dy. Collector (HQ), Daman and Shri Vinod P Kavle, Collector, Diu Assistant Returning Officers have also been authorized to received nomination papers at his office at the Collectorate, Daman & Collectorate Diu respectively during the period mentioned above.
2. The Nomination forms can be available from the office of the Returning Officer during date and hours of making nomination as stated above.

3. All nomination papers received by Returning Officer and the authorized Assistant Returning Officer will be taken up for scrutiny by the Returning Officer himself on 10-04-2014 at 11:00 A.M. at his office at Collectorate, Daman
4. If a nominated candidate intends to withdraw his nomination a notice of withdrawal of candidature in Form 5 should be delivered either by to the Returning Officer or to the Assistant Returning Officer specified above at his office. The last date of withdrawal is up to 03:00P.M. On 12-04-2014.
5. In the event of contents, the date and hours of poll will be as under:-

Hours: Between the hours of 07:00A.M. and 06:00 P.M.

- (1) An election is to be held of a member to the House of the People in the 1-Daman & Diu Parliamentary Constituency.
- (2) Nomination paper may be delivered by a candidate or any of his proposers to the Returning Officer or to Shri Vinod P Kavle, IAS, Assistant Returning Officer at Collectorate, Diu or Shri Gaurav Singh Rajawat, IAS, Dy. Collector (HQ), Daman Assistant Returning Officer at Collectorate, Daman between 11A.M. to 3 P.M. on any day (other than public holiday) not later than the 09th April, 2014.
- (3) Forms of nomination paper may be obtained at the place and time aforesaid.
- (4) Nomination paper will be taken up for scrutiny at 11 A. M. on the 10th April, 2014 at Conference Hall, Collectorate, Daman
- (5) Notice of withdrawal of candidature may be delivered either by a candidate or his proposers or his election agent who has been authorized in writing by the candidate to deliver it to either of the officers specified in paragraph (2) above in his office before 3 P. M. on the 12th April, 2014.
- (6) In the event of the election being contested, the poll will be taken on 30th April, 2014 between the hours of 7 A.M. and 6 P.M.
