**PERMISSION**

Whereas this office are in receipt of two Applications (1) from Shri Vasubhai S.Patel, BJP, President, Daman, received at 1.25 p.m. to hold Public Meeting by their Star Campaigner Shri Narendra Modi and (2) from Shri Keyur Pathak, Congress candidate Co-ordinator, 1-Daman & Diu Parliamentary Constituency, Daman, received at 2.50 p.m. to hold Pubic Meeting by T.V. Stars for campaigning of Congress Party at Dilip Nagar Ground, Nani Daman on 26/04/2014.


And whereas, in their application, applicants have mentioned that the number of public gathering expected in the BJP Public meeting is about 10,000 and in Congress Public meeting is about 1,000.

**And whereas, the Superintendent of Police, Daman through his detail report No. SP/DMN/2014/ELECTION/356 dated 21/04/2014 has recommended that Public Meeting to be addressed by Shri Narendra Modi at Dilip Nagar Ground, Nani Daman from the Law & Order point of view and the number of public gathering expected.**

Therefore, in view of above and taking into consideration the policy of first come first served, issued by this office Order No.COL/DMN/RALLY/LS-2014/213 dated 21/04/2014, permission is hereby granted to Congress Party, Daman to hold Public Meeting by T.V. Stars from 11.00 a.m. to 2.00 p.m., at the **Football Ground** at Moti Daman on **26/04/2014**, as their public gathering is less and it can be easily accommodated at Football ground.

Permission is granted subject to the following conditions:-

1.	The Audio System shall not exceed the permitted decibel limits as per Hon'ble Supreme Court directions and shall not cause any inconvenience to the nearby residents and general public.
2.	No hate speech of slogan shouting against any religious/ethnic/minority groups or community shall be used during the meeting/campaign.
3.	The Organizers shall deploy sufficient number of volunteers to help in regulating vehicular and pedestrian movement.
4.	Applicant shall be responsible for any untoward incident/breach of peace etc.
5.	Organizers shall follow the instruction of Police Officer on duty.
6.	The permission is liable to be cancelled or revoked at any time.
