**ORDER**

**WHEREAS**, with a view to ensure peaceful conduct of the ensuing General Election to Lok Sabha -2024, I consider it necessary to suspend all the licenses of Arms and Ammunition in the District of Daman from the date of issue of this order till 06/06/2024.


**THEREFORE**, I, **Saurabh Mishra, District Magistrate, Daman** in exercise of the Power vested in me under **Section 17(3) (b) of the Arms Act, 1959** as applicable to the Union Territory of Dadra & Nagar Haveli and Daman & Diu, hereby suspend the Arms and Ammunition licenses of Daman District and further order the license holders to deposit their Arms and Ammunition within **07 days** with the Officer-in-charge, Daman Police Station, Nani Daman and Moti Daman till 22<sup>nd</sup> March, 2024.

The Sub-Divisional Police Officer, Daman is hereby directed to issue necessary instructions in this regard to all concerned to take into custody Arms and Ammunitions possessed by the license holders during the period of suspension of license.

The license of any license holder who fails to deposit his/her weapon within the prescribed period shall stand cancelled automatically without further notice.

However, the Police/CAPF Personnel on duty and Banks would be exempted from this order.

All the Arms and Ammunition shall be released on 07<sup>th</sup> June, 2024.
