Both of the injured BJP workers were sent to the Primary Health Centre, Ghoghla for medical examination. As reported by the COP, Diu, the Medical Officer, PHC, Ghoghla certified them as a case of simple injuries. |

Immediately, on receipt of the complaint, District Magistrate, Additional District Magistrate and Chief of Police reached the spot. The vehicles alongwith the alleged Congress workers were handed over to the Police for further necessary action in the matter. The whole incident happened around the 4.50 p.m. 500 mts. away from the nearest Polling Station and the Poll
